

SCHOOL FEE SPECIFICATIONS FOR LOCAL & NATIONAL BOARDING STUDENTS 2022-2023

- Registration fee is required for initial enrolment only.
- Specified fees include the following services: (Boarding students)
 - School tuition
 - o Three meals per day
 - Housing
 - o Books

Specified fees do not include the following:

- Stationary materials
- School uniform and gym attire
- Domestic trips offered throughout the year
- Clubs fee
- Personnel expenses
- Bedding, Hygiene and Sanitary items

Refund Terms and Conditions:

- If student is unable to secure his/her admission before the school start, all money paid, less \$ 250, will be refunded.
- o No refunds will be made money for the month the student leaves.

Health Insurance:

- o Obligatory on an annual basis for all boarding students.
- For the Insurance carrier we use for our boarding students (premium paid by parent/guardian); the parent/ guardian is responsible for all deductibles, copays and services not covered by the insurance.
- Health Insurance must be paid for provided by the parents.



SCHOOL FEE AND PAYMENT SCHEDULE
